#### **Job Description:**

The Court of Appeals, Third District of Texas, is accepting applications for a staff attorney position for Chief Justice Jeff L. Rose and Justice Bob Pemberton. A staff attorney's primary duty is to assist the Court in research and preparation of draft opinions and judgments in selected cases. In addition, a staff attorney may be called upon to review and screen original proceedings and motions, prepare pre-submission memoranda in selected cases, review appellate records submitted for filing, conduct legal research to assist the Court in the disposition of appellate issues, review current developments in the law, and assist the Clerk in his administrative duties.

#### **Job Requirement:**

- Applicants must be currently licensed to practice law in Texas, preferably have at least three years of practice experience, and have a strong background in appellate procedure, legal research, and writing. Law review/journal experience, judicial clerkships, or similar research and writing-intensive background is preferred.
- A strong work ethic, exacting analytical skills, attention to detail, and clarity and precision in thinking and writing are essential.
- Graduation from an accredited law school with a Bachelor of Laws or a Juris Doctor degree.
